Għeziez ġenituri/ kustodji,

Nispera li tinsabu tajbin. **Nhar it-27 ta' Settembru** ser nibdew sena skolastika ġdida fiċ-Ċentru tar-Rizorsi tal-Wardija u m'għandniex dubju li ser inkunu qegħdin naħdmu id f'id għall-ġid ta' wliedkom! Malli l-eskorti ikollhom id-dettalji tax-xufiera tal-vann, dawn jikkuntatjawkom (ġeneralment d-dettalji jingħataw ġurnata qabel jibdew l-istudenti). L-eskorti jkunu qegħdin jikkuntatjawkom biex jiftehmu magħkom dwar kif ser ikun qed jaħdem it-trasport u r-rotta li tkun stabbilita mix-xufier. Importanti li kull filgħodu ġenitur ikun preżenti mat-tifel/tifla tiegħu qabel dan jew din jitolgħu fil-vann. **L-eskorti biss** huma l-punt ta' referenza tagħkom dwar bżonnijiet li jinqalgħu rigward it-trasport. **Importanti li l-udenti godda, ikollhom tag b'isimhom u kunjomhom viżibbli.** Malli l-eskorti ser ikollhom id-dettalji tar-rotta, li dawn jiġu provduti mid-dipartiment tal-edukazzjoni (sezzjoni trasport), l-eskorti ser jinfurmawkom minnufih. Għall-ewwel granet, stennew il-vann mit-8 am il-quddiem.

L-istaff ser ikun jikkomunika magħkom permezz tal-imejl tat-tifel/tifla tagħkom. **L-email address ser jingħata lilkom fl-ewwel ġurnata li t-tifel/tifla tiegħek j/tattendi l-iskola.** Kunu ċerti li qed jaħdem sewwa u jekk le infurmaw lill-għalliema tal-klassi mill-ewwel. Huwa l-obbligu tagħkom li dan tarawh kuljum u twiegħbu. Qegħdin nitolbukom tixtru *stationery* u materjal edukattiv skont kif ser jgħidulkom l-għalliem/a, dan biex kollox ikun personalizzat.

Ser inkunu qed ngħaddulkom formuli ta' kunsens. Importanti li dawn jimtlew tajjeb u jintbagħtu lura f'envelop b'isem it-tifel/tifla tagħkom **sal-4 ta' Ottubru.**

Nixtieq ukoll niġbed l-attenzjoni biex kull min jixtieq jgħaddi **xi mediċina lin-ners tal-iskola dan għandu jnewwel il-mediċina f'idejn l-eskorti direttament f'borża nadifa u personalizzata bl-isem u l-kunjom tal-istudent u mhux ipoġġiha fil-basket tal-iskola. Hija responsabilità tagħkom li bħala ġenituri żzommu lin-ners infurmat/a b'mediċini (u tibdil ta' mediċini) li jużaw uliedkom kemm matul il-ġurnata tal-iskola u wara.** Huwa importanti wkoll li l-mediċini, kif ukoll l-oġġetti personali (eż. ħwejjeg) ikunu dejjem immarkati bl-isem u kunjom tal-istudent/a (isem l-istudent/a irid ikun ċar. Huwa importanti li tibagħtu ma' wliedkom tibdila ta' ħwejjeg f'kaz li jkun hemm bżonn urgenti.

Nhar it-**11 ta' Ottubru fid-9.30am** ser ikollna l-ewwel laqgħa informattiva għalikom il-ġenituri u din ser issir ġewwa s-sala tal-iskola. F'din il-laqgħa ser inkunu qegħdin nispjegaw kif ser naħdmu f'din is-sena skolastika. Grazie.

Dear parents/carers,

On **27th September** we will start another new scholastic year at the Wardija Resource Centre. I trust that you are well and will continue to support us in order that your son/daughter gets the best of our educational activities! It is extremely important that daily, a parent/guardian keeps waiting with his/her son/daughter up until the van comes. The escorts will contact you later to inform you about pick up time and how the transport route shall work – which is set by the driver. Generally such details are forwarded to us a day before school starts, so please bear with us. Kindly be reminded that **only the escorts** shall be the point of reference if any problems arise during transport. **It is very important that the new students have a visible name tag.** When the escorts have all the route details, which routes are provided by the education department (transport section), the escorts will inform you immediately. For the first scholastic days wait for the van from 8 am onwards.

Staff will be communicating via the email address of your son/daughter. **The email address will be given on the first day of school.** Kindly make sure that the email is functioning accordingly and if not to inform the class teacher immediately. It is your duty to access emails every day and acknowledge email.

We are kindly asking you to provide personalized stationery and educational material as per teacher's request.

We will be sending you consent forms which we expect that they are duly filled and returned by **the 4th October.**

Please be informed that all medicines/pills should be directly given (by hand) to the van escorts and **should not** be put inside the students' bags. **The medicine should be put in a clean and labelled plastic bag.** The escorts will then forward the medicine/pills to the Centre's nurse. Please be reminded that it is within your responsibility to inform the school nurse about medication changes and any medication which your son/daughter takes. It is also important, that the students' belongings are properly labelled with the student's name and surname (ex. clothes). Ideally, all students should have an extra outfit according to the student's needs as indicated by the group's staff. This should also be labelled.

On **11th October at 9.30am** we shall be holding our first informative meeting with parents. This will be in the school hall. Throughout, I will explain general outcomes for this scholastic year.
